Summary

Professor Manuel B Graeber (the Applicant) applied for information from the NSW Ombudsman (the Agency) under the Government Information (Public Access) Act 2009 (GIPA Act).

The Agency decided that the application was invalid because the Applicant had made an application for excluded information.

The Applicant applied for an external review by the Information Commissioner on 30 October 2024.

The review of the Agency's information and decision concluded that its decision is justified.
